## HAWKINS COUNTY 2022 PUBLIC INFORMATION AND EDUCATION PLAN

- 1. The 2022 MS4 Permit requires adoption of a Public Information and Education Plan and specifies minimum criteria. This plan will incorporate those requirements at a minimum which will apply to the urbanized areas (UA) of the County as designated by the US Census Bureau and the Highway Department property on Flora Ferry Road.
- 2. The County will use the County web site to disseminate information and participate in the Tennessee Stormwater Association (TNSA) Education Program to meet these minimums. First, the amount of funds needed will be identified and requested. Upon receipt, educational materials and supplies will be obtained. Thereafter, stormwater information will be provided at public events such as festivals, block parties and the like in the UA as well as on the County web site. This information will target the issues and be aimed at the audiences specified below:

Multiple issues and audiences may be addressed at any one event.

- 3. Records of these events will be maintained. Participation will be measured by counts of the educational material available at the beginning and end of each event. A separate count for each item will be maintained (e.g. 100 copies of fact sheet XYZ available at beginning and 75 and end shows 25 taken and success; if none taken, redesign or use a different means at the next event). A voluntary attendance list will also be available with those signing maintained for future information notice.
- 4. The County will also encourage public participation by announcing educational events, UA sub-division considerations and Stormwater program development, and major changes to the stormwater program on the County web site and by public notice. Hawkins County public notice consists of posting an event notice on three bulletin boards—this is the process that will be used unless a newspaper notice is required by law/rule. Comments received will be considered and provided response. The SWMP and PIE as well as BMP information will be provided on the County web site along with contact information. The County web site will also continue to provide the public a means to report illegal spills, discharges and illegal dumping as well as other illegal disposal of materials into the storm sewer system.
- 5. The County has identified the job categories of employees whose duties require stormwater training. These are employees of the Highway Department excluding office staff. These employees will receive training which will inform them of how to identify pollutants, how to reduce pollutants and how daily activities they engage in can have an impact on water quality. Training method may be to watch a video or read a hand out or attend an in-person training session. Records of training to include the date, topic and name of each attendee will be maintained. Each current (December 2022) identified employee will attend a minimum of one event during the permit cycle (September 2022 September 2027) and a record of that training maintained. All new hires or transfers in will attend an event during the first 6 months of employment with a record maintained. Additional training is encouraged.
- 6. The County will address audiences and target audiences as shown below as part of the public education and outreach (Multiple issues/audiences may be addressed at any one event):
