PASSPORTS

Passport Application (DS-11) can be obtained from the **Hawkins County Chancery Court** or at <u>www.travel.state.gov</u>.

WE CANNOT ACCEPT CASH OR DEBIT/CREDIT CARD AS PAYMENT.

When applying for a **<u>Passport Book</u>**, you must have:

- Application completed in BLACK INK. DO NOT SIGN.
- **Certified birth certificate with seal** (must be raised or multicolored and cannot be a hospital record). Also, please provide a copy of the birth certificate (both sides if contain writing).
- The birth certificate must list your mother's and father's full name. The birth certificate is mailed with the passport application and will be returned to you in a separate mailing.
- One 2x2 passport photo We take passport photos at a cost of \$15.
- Driver's license or government ID (and a copy of both sides), preferably with photo.
- <u>\$130.00</u> check or money order payable to <u>U.S. Department of State</u> for adults and minors 16 or over.

<u>\$ 100.00</u> check or money order payable to <u>U.S. Department of State</u> for minors age 15 and under.

- <u>\$35.00</u> cash, check or money order payable to <u>Chancery Court plus \$15.00 if we take the photo</u> for a total of \$50.00.
- Everyone applying for a passport MUST appear in person, including infants and minors. If a minor is under 16, both parents have to be present or the parent who is not present must complete a consent form which can be obtained at our office or downloaded at <u>www.travel.state.gov</u>.

PASSPORT CARD (A passport card is valid only for travel by land and by sea to the

following locations: Canada, Mexico, Bermuda, and the Caribbean.)

- Application completed in BLACK INK. DO NOT SIGN.
- **Certified birth certificate with seal** (must be raised or multicolored and cannot be a hospital record). Also, please provide a copy of the birth certificate (both sides if contain writing).
- The birth certificate must list your mother's and father's full name. The birth certificate is mailed with the passport application and will be returned to you in a separate mailing.
- One 2x2 passport photo We take passport photos at a cost of \$15
- Driver's license or government ID (and a copy of both sides), preferably with photo.
- <u>\$30.00</u> check or money order payable to <u>U.S. Department of State</u> for adults and minors 16 or over.
- <u>\$15.00</u> check or money order payable to <u>U.S. Department of State</u> for minors age 15 and under.
- <u>\$35.00</u> cash, check or money order payable to <u>Chancery Court plus \$15.00 if we take the photo</u> for a total of \$50.00.
- Everyone applying for a passport MUST appear in person, including infants and minors. If a minor is under 16, both parents have to be present or the parent who is not present must complete a consent form which can be obtained at our office or downloaded at <u>www.travel.state.gov</u>.

We can take your photo for passport renewals and provide the form (DS-82), however, the applicant must submit the form personally and not through our office.

It takes 10-13 weeks to receive your passport. If you need your passport sooner, you can expedite your application, which takes 7-9 weeks.

To expedite your application:

• <u>16 years old and older:</u>

<u>\$209.53</u> (\$130.00 passport fee + \$60.00 expedite fee + \$19.53 return overnight mailing fee) Make check or money order payable to the U.S. Department of State.

• Minors under age 16 years old:

\$179.53 (\$100.00 passport fee + \$60.00 expedite fee + \$19.53 return overnight mailing fee) <u>Make check or money order payable to the U.S. Department of State.</u>

- \$35.00 cash, check or money order payable to Chancery Court <u>for each application.</u> (Plus \$15 for photo if we make it.)
- \$28.75 for two-day delivery of your application. <u>Make check or money order payable to the U.S.P.S.</u>
