- 4. Social Security card.
- 5. \$199.50 filing fee. This fee covers two certified copies of the court order.

(NOTE: If you were divorced in Chancery Court and are trying to go back to your maiden name, you can file the petition in the divorce action and the filing fee will be \$102.00.)
